Lord Taylor Hosts 'Britishness' Debate

On Thursday 19th June Lord Taylor hosted a debate in the Lords entitled 'Britishness'. This was an extremely popular topic with numerous peers responding to Lord Taylor's discussion, in the context of the cultural, historical, constitutional and ethical tradition of the peoples of these islands.

Lord Taylor described the immigrant's perspective of his father's journey to Britain. He defined the concept of Britishness as something tied neither to blood nor soil, but rather developed through common national values. Lord Taylor then suggested the strengthening of the bond of Britishness through several methods. They included the further promotion of the English language and increased partnership with faith, charity and other voluntary groups. He also emphasised the need for more multi-racial role

The debate highlighted the subjectivity of Britishness with fascinating anecdotes about religion, family and community. There was consensus that care needs to be taken that Britain does not "sleepwalk its way to segregation", and that emphasis should be placed on celebrating both similarity and difference.
